Membership Application Guidelines & Policies

- Waiver: REQUIRED (30 DAYS)
- Individual Shareholder is allowed to own only one (1) share
- Life Membership: 25 years
- Proposer/Secunder: Required
- Posting period: 30 days
- Dependents' age limit: up to 25 years old; unmarried
- Stock Certificate: 1 month
- With non-refundable Pre-qualification fee of P20,000 (part of the Transfer Fee) effective June 01, 2015
- Schedule of monthly interview: Every 2nd Thursday of the month
- Membership Card:
 - Temporary/privilege card will be given to the member upon interview that will expire within 90 days from issuance.
- Permanent card will be issued during induction
- Earliest time to use the facilities: Upon issuance of temporary card/privilege card
- Both A and B shares can be leased out to foreigners
- Foreigners cannot buy an A share but Filipinos can **buy a B share**
- Both A & B shares can be placed under corporate name
