Membership Application Guidelines & Policies

- Waiver: NOT REQUIRED
- Proposer/Seconder: Required
- Posting period: 30 days
- Seller's DEPOSIT: required upon submission of the Deed of Sale to guarantee payment of the Seller's outstanding account. The refund of the DEPOSIT shall be processed after the release of the clearance of the account.
- Normal processing time: 2 months
- Dependents' age limit: up to 24 years old; unmarried. For Playing rights member the dependents that can be declared is limited to 2 unmarried children only
- Initial interview:
 - Applicant shall be interviewed by any three (3) of the five (5) members of the membership committee
- Temporary Card:
 - (good for 30 days) shall be issued after the initial interview, for proprietary member & company representative only.
- Membership Card: processing of permanent card is 3 weeks.
- Stock Certificate: 1 to 3 months.
- After the initial interview, the applicant shall be invited to attend the "meet the board social" which is usually held every last Sunday of the month following the date of the initial interview.

CLUB PROCESSING

- Interview- by schedule; once a month
- Posting Period – will start 1 day after the interview
 - *30- day posting for Proprietary/ Corp. Representative applicants
 - *60- day posting for Playing Rights applicants
- Approval- 3rd Saturday of the following month after posting
- Cocktail Party - meet the board, 3rd Saturday of the following month after approval
- Issuance of Temporary Card – Account number will be given after the interview
- Issuance of Permanent Card - during the cocktail party
- Issuance of Stock Certificate - 1 - 1/2 months after approval. Transfer agent: San Miguel Corp.
